Dear Secretary of State,

I am writing on behalf of Rushmoor Borough Council in response to the Government's consultation on its proposed approach to local authority funding reform through the Local Government Finance Settlement from 2026 to 2027.

This Council supports the core principle of the Fair Funding review that funding should be distributed to where it is most needed. It welcomes the increase in local government core spending power announced in the Spending Review, including rolling in other government grants to end wasteful competitive bidding and unnecessary administrative burdens.

It further believes that meaningful transitional arrangements will promote long term financial sustainability of local public services. Well-designed arrangements will maintain the ability of local authorities to set a balanced budget for next year. In our view, any transitional arrangements should support the early years of unitary local government.

You recently launched the Local Government Outcomes Framework setting out how the Government expect to work with local authorities to deliver key national priorities for local people and communities. The distribution of funding to councils should enable the Council to make meaningful and timely progress against these outcomes.

The Council supports the comprehensive and detailed consultation response provided on its behalf by the District Councils Network. It would like to highlight some particularly relevant points, namely:

- The collection rate assumption should be based on actual collection rates, not on full collection.
- To retain the New Homes Bonus as an incentive to support the delivery of the Government's housebuilding mission.
- To provide additional freedoms and flexibilities for councils to raise and retain income locally, including greater flexibility to set fees and charges, and to recover the full cost of providing services.
- To extend transitional arrangements given that most district councils will lose from the funding reforms and that this may endanger the successful implementation of unitary local government.

We look forward to your response to our feedback.
